Official Sweepstakes Rules, Terms & Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Promotion Description: The 2018-2019 Free Fujitsu 24K Multi Heat Pump Giveaway (“Sweepstakes”) is sponsored by Hometown Heat Pumps, Inc located at 353 S. Horseback Rd, Burnham, ME 04922. Entrants should look solely to sponsor with any questions, comments, or problems related to the Sweepstakes. 2. Eligibility: This Sweepstakes is open only to those who are at least 18 years of age as of the date of entry, and a Maine resident. Commercial buildings are not eligible, only residences. Employees of Hometown Heat Pumps, Inc., its affiliates, subsidiaries, advertising and promotion agencies, employee’s immediate family members, and owners and employees of other Maine companies that install heat pumps are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. Agreement to Rules: By participating, the person entering (“You”) agree to be fully and unconditionally bound by these Rules, Terms & Conditions, and You represent and warrant that You meet the eligibility requirements and have affirmatively reviewed, accepted, and agreed to all of the Official Rules, Terms & Conditions. Grand Prize: The Winner of the Sweepstakes will receive a Free Fujitsu Ductless Mini-Split Heat Pump System with basic installation described as an AOU24RLS3 outdoor unit with 2 indoor heads of any combination, as determined for proper sizing of winner's residence, ASU7RLS3, ASU9RLS3, ASU12RLS3, or ASU15RLS3. Basic installation includes labor, electrical, disconnect, up to 50' of line set and slim duct, wall bracket mount and rain cap. Retail value without utility rebates is approximately \$6000. A site visit will be done at Winner's residence prior to installation to determine the best size, run and location for the heat pump units. If it is determined that changes need to be made to the equipment due to location, preference and/or square footage of the Winner's residence to ensure proper heating efficiency and operation, or Winner needs to add any other accessories, electrical upgrade, or installation materials for proper installation of the heat pump unit at Winner's residence, Winner will be given the opportunity to upgrade the system for the cost difference. Hometown Heat Pumps, Inc. may substitute a cash prize at their discretion in extenuating circumstances.

If in the event the Winner has already had a heat pump installed by Hometown Heat Pumps, Inc. prior to selection of the Winner and it is determined by Hometown Heat Pumps, Inc. that the grand prize cannot be properly installed in the Winner's home due to limitation on available space, square footage, etc., Winner will be given the opportunity to select an alternate cash prize at Hometown Heat Pumps, Inc.'s discretion. Cash prize is to not exceed the retail value of the grand prize. The Winner of the second drawing will receive \$500 off a ductless mini split heat pump installation. Retail value is \$500. If in the event the Winner has already had their heat pump installed by Hometown Heat Pumps, Inc. from December 1, 2018 to February 28, 2019, Winner will be given the opportunity to select an alternate cash prize of \$500. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No other prize substitution, transfer/assignment of prize to others or request for the cash equivalent by Winner shall be permitted

unless as otherwise stated in the Official Sweepstakes Rules, Terms & Conditions or at Hometown Heat Pumps, Inc.'s discretion.

Retail value is \$650. If in the event Winner has previously purchased a labor warranty from Hometown Heat Pumps, Inc., Winner will be given the opportunity to select an alternate cash prize not to exceed the original amount the Winner had paid for the labor warranty. Warranty term starts from the date the heat pump was installed.
